

Dear colleagues,

We would like to inform you that as of May 8, 2024, amendments and additions to the Laws of the Republic of Armenia "On Medicinal Produces," "On Medical Aid and Population Services," and "On State Duty" entered into force. According to these amendments, a state duty is now charged for expertise in the field of state regulation of the medicinal products and medical devices circulation, in accordance with the procedure and amount established by the Law "On State Duty".

According to Article 20.3 of the Law "On State Duty", a state fee is paid at established rates for conducting expertise in the field of regulating the medicinal products and medical devices circulation, for maintaining the registration in force under the EAEU procedure and for accepting the notification of changes that do not require examination.

Payments at the rates set by Article 20.3 of the Law "On State Duty" must be made to the following account: Account Number 900005003125 (recipient: the State Budget of the Republic of Armenia).
